

Training Programme in the domain of security For a delegation from the Beijing Municipality

The programme is organized by ECMI foundation in collaboration with the Geneva Municipal and Cantonal (i.e. Provincial) authorities, and Professors of the University of Geneva

Duration and dates

The training programme will last 5 working days between November 12 and 20.

Location

Geneva, Switzerland, in meeting rooms provided by the Geneva Municipal Government and/or other Geneva institutions.

The participants

This programme is meant for a delegation of high officials from the Beijing Municipality, in charge of justice and security, i.e. law making dealing with justice and security, law implementation by local authorities (namely local administrations, courts, procuratorates, and police).

The organization of the programme


The programme will comprise a series of seminars and visits at local public administrations in Geneva, at both the municipal and cantonal level. As in Switzerland security problems are dealt with by municipalities and cantons (equivalent to the Chinese Provinces), the topics will cover both municipal and provincial administrations. It will be also possible to organize social and cultural activities (receptions by local authorities and during the week-end following the seminar).

In the mornings (from 9.00 to 11.45) there will be seminars given by experts, and followed by a period of "questions & answers" so that the participants can obtain additional information suitable to their needs.

In the afternoons (from 14.15 to 17.00) we will organize visits of public authorities, like police stations, prisons, tribunals, etc. Brief presentations will be made by municipal and provincial experts. The participants will be able to ask questions and obtain additional information suitable to their needs.

The experts

The seminars will be conducted by high civil servants from the municipal and provincial administrations, eventually also by university experts. After each seminar there will be a period of questions and answers, so that the participants will be able to discuss with the experts.
